Order:

In the letter first read above, Secretary, Lord Balaji Educational and Charitable Trust, Salem has requested the Government to grant permission to the Trust to start a Homoeopathy Medical College in the name of "Dr. Hahnemann Homoeopathy Medical College and Research Centre" at Konneripatty Village, Rasipuram taluk, Namakkal District.

2. In the letter second and third read above, the Registrar, Tamil Nadu Homoeopathy Medical Council has stated that a Committee headed by Dr. S.P. Kapihar has inspected the site of the proposed College and submitted a report. The Tamil Nadu Homoeopathy Medical Council considered the inspection report on the proposed Hahnemann Homoeopathy Medical College and Research Centre at Rasipuram, Namakkal District by Lord Balaji Educational Trust in detail and the Council was fully satisfied with the minimum requirements/norms available in the Lord Balaji Educational Trust, Salem, particularly Land, building and financial capacity of the Trust for starting I BHMS., course in the proposed Hahnemann Homoeopathy Medical College and Research Centre at Konneripatty Village, Rasipuram taluk, Namakkal District. The Council has expressed the view that the management of Lord Balaji Educational Trust, Salem is financially sound. The President, Tamil Nadu Homoeopathy Medical Council has therefore recommended to the Government that permission may be accorded to start Homoeopathy Medical College by Lord Balaji Educational and Charitable Trust at Konneripatty Village, Rasipuram taluk, Namakkal District.

3. The Commissioner of Indian Medicine and Homoeopathy has opined that the Member of the Lord Balaji Educational and Research Trust are very much keen and interested and are also capable of placing the funds for running the college and therefore, he has recommended to grant permission to Lord Balaji Educational and Charitable Trust to start a Homoeopathy College at Rasipuram taluk, Namakkal District.

4. The Government have examined the above proposal carefully and decided to accept the recommendation of the Registrar, Tamil Nadu Homoeopathy Medical Council. Accordingly, the Government permit Lord Balaji Educational and Charitable Trust, Salem to start Homoeopathy Medical College in the name of Dr. Hahnemann Homoeopathy Medical College & Research Centre at Komeriapatty Village, Rasipuram taluk, Namakkal District subject to the fulfilment of the following conditions, failing which the permission granted is liable for cancellation:-

- (i) the Trust should make arrangements to construct additional building and provide necessary infrastructure facilities at the new site within a year;
- (ii) the Trust should fulfil the minimum standards prescribed by the Central Council of Indian Medicine;
- (iii) the Trust should fulfil the norms of the Tamil Nadu Dr. M.G.R. Medical University for affiliation with the University;
- (iv) the selection and admission procedure of Government as per the scheme of admission enunciated by the judgement of the Supreme Court of India should be followed strictly and
- (v) there will be no financial aid from the Government at any time, and
- (vi) the admission strength should not exceed 50 students(fifty) per year.
